



# Accounting, Information, and Financial Crises Call for Papers

The Research Group on "Financial Crises" of the Österreichische Forschungsgemeinschaft and the Center for Accounting Research at the University of Graz invite submissions of research papers on the recent financial crises of the new millennium for a workshop on "Accounting, Information and Financial Crises" held at the University of Graz at November 4-5, 2015.

While theoretical and empirical contributions on all topics related to financial crises are welcome, a focus is placed on the role that accounting information plays particularly in periods of crises for the behavior in financial markets and of financial institutions. Topics of interest include but are not limited to:

- Transparency and financial crises
- Procyclicality, investor herding and accounting rules
- Information about risks and risk management
- Accounting rules, fire sales and contagion
- Price discovery in financial crises
- Performance measurement and incentives in financial institutions
- Earnings management in accounting for financial instruments
- Accounting standards and regulatory capital requirements
- Interactions of accounting and corporate governance
- Information and cost of capital
- Accounting for financial innovations
